### 2. Unit aims and outline

In this unit you will gain practical work-based experience working with a range of patients and clients. You will have the opportunity to apply your theoretical knowledge and skills that have been developed while studying other units on this course, applying them in practical environments and utilising your transferable skills. This practical placement unit is composed of two separate 7-week placements focused on a specific area of physiotherapy practice. In the unit you will actively contribute to the assessment and treatment of service users.

### 3. Intended Learning Outcomes

Having completed this unit, you will be able to:

- Apply interpersonal skills with patients/clients and colleagues in multi-disciplinary teams.
- Demonstrate the ability to safely apply clinical skills in the assessment and treatment of patients and be able to evaluate intervention effectiveness.
- Synthesise and apply theoretical knowledge and evidence to inform practice.
- Apply clinical reasoning skills by identifying and prioritising problems, planning treatments and goal setting.
- Appraise the structure and function of health and social care services in the UK.
- Demonstrate an understanding of the process of continued professional development, planning and reflective practice

#### 4. Indicative content

- Induction, orientation, practical and professional issues
- Health and safety legislation and safe practicing environments
- Legal ethical and local considerations of professional practice including clinical information (CSP, 2011; HCPC, 2016)
- Therapeutic relationships, and service user consent
- Awareness of physical, psychosocial, and cultural needs
- Relationship-building
- Professional communication skills: verbal, non-verbal, listening, writing skills
- Individual learning needs, areas for development and the means for addressing these
- Reflective approaches to practice and responding appropriately to feedback
- Managing own workload (appropriate to the practice environment), and respond to varying circumstances in a professional manner
- Accountability and knowledge of own professional and personal scope of practice; whilst recognising and acknowledging the contributions of team members to the patient/client centred approach
- Apply appropriate physiotherapy assessment, diagnosis and treatment strategies and management plans
- Monitoring and review of activity and intervention
- Patient-centredness
- Recognition of clinical features
- SMART goal setting and motivation
- Treatment planning
- Clarity and clinical reasoning in documentation
- Deliver and evaluate physiotherapy programmes
- Select and apply safe and effective physiotherapy-specific skills (e.g., manual therapy, exercise and movement etc)
- Responding to emerging and/or changing contexts

The unit will be predominantly placement based with Practice Link Educator support. Learning will be encouraged through student centred activities including online materials, directed learning and experiential reflections.

## Indicative assessment

In the first assessment you will complete two 4000-word equivalent practice placement portfolios (one for placement 1 and one for placement 2) that will include a placement report by the Practice Placement Educator from each of the two placements undertaken. For the second assessment you will complete a 2000 word Continuing Professional Development (CPD) e-portfolio, one at the end of each placement. This will consist of a range of relevant planning and reflective tasks. In order to pass the unit you are required to pass both elements of the assessment.

## Indicative feedback methods

For formative tasks you will receive verbal feedback from peers as part of a 'peer review' process for the CPD e-portfolio and the Practice Placement Educators for the Practice Placement e-Portfolio. Feedback on the final summative tasks will be written and returned electronically to you.
