

Partner Student Privacy Notice

This privacy notice concerns our processing of personal data of past, present and prospective students of Health Sciences University (HSU) who undertake their studies at one of our approved Educational Partners. It explains how HSU collects, uses and shares your personal data, and your rights in relation to the personal data we hold.

If you are studying your course at a partner organisation but are enrolled directly with Health Sciences University, HSU is the data controller of your personal data and is subject to the General Data Protection Regulation (GDPR) and the Data Protection Act 2018. We will share data with the partner and they will act as a data processor. If you are enrolled with our partner for an HSU award, the partner will be subject to the GDPR and Data Protection Act 2018, whether they are acting as the data controller or the data processor.

The University needs to collect, process and use personal data (information) for a variety of purposes about those who express an interest in becoming a student of the University (prior to application and enrolment stage) and those who become enrolled students of the University and after students have graduated.

The University and our partners take the matter of data security and protection extremely seriously. The personal data you provide to us or to our partner provider during the application and enrolment procedure and throughout your time as a student is securely held by the University and our partners and will be treated confidentially.

How we collect your information

We collect your personal data in a number of ways, for example:

- from the information you provide to us before joining, for example when you enquire about studying at Health Sciences University or for an award of HSU, delivered by one of our partners;
- when you apply to study at Health Sciences University or for an award of HSU, delivered by one of our partners; and complete an application via the Universities and Colleges Admissions Service (UCAS), the University's application portal and when you complete other admissions processes and procedures;
- when you communicate with us by telephone, email or via our website, for example in order to make enquiries or raise concerns;
- in various other ways as you interact with us during your time as a student of HSU, or one of our educational partners for the various purposes set out below;
- from third parties, for example from your previous or current school, sixth form college, university or employers who may provide a reference about you or who may sponsor your studies.

The types of information we collect

Health Sciences University and our approved Educational Partners may collect the following types of personal data about you:

- your name, and contact information such as address, email address and telephone number, as well as your date of birth, national insurance number (or other tax identification number) and your passport number or national identity card details, country of domicile and your nationality. We will also allocate you a unique student number;
- If you apply directly to HSU, we will collect information relating to your education and employment history, the school(s), sixth form college(s) and other colleges or universities you have attended and places where you have worked, the courses you have completed, dates of study and examination results. We will also keep records relating to assessments of your work, details of examinations taken, your predicted and actual examination grades and other information in your student record; if you apply directly to a partner they will collect this information.
- If you apply directly to HSU, we will collect information about your family or personal circumstances, and both academic and extracurricular interests, if you apply directly to a partner they will collect this information;
- If you apply directly to HSU, we will collect special category personal data, including:
 - information concerning your health and medical conditions (e.g. disability and dietary needs);
 - information about your racial or ethnic origin; religion or similar beliefs; and sexual orientation;
 - if you apply directly to a partner they will collect this information.
- If you apply directly to HSU, we will collect special category personal data, including:
 - certain criminal convictions (e.g. for courses leading to professional registration, following completion of an annual declaration of “good character”);
 - if you apply directly to a partner they will collect this information.

How we secure personal information

The University takes data security seriously and uses appropriate technologies and procedures to protect personal information. Our information security policies and procedures are reviewed regularly and updated as necessary and respond to changes in technology and regulatory requirements. If you are enrolled with a partner provider, they will also follow policy and procedure which reflects HSU requirements, and these will be under regular review

How we use information about our students

The University and our approved Educational Partners collect only the data needed and we keep that data up to date and only for as long as it is needed. The University and our approved Educational Partners collect data from applicants and students themselves through application forms and other means, as well as through other third parties such as schools or admissions services.

The University and our approved Educational Partners need to process certain personal data about applicants and students for a number of purposes in order to support your time studying with us, whether you attend the University campus or study at one of our approved Educational Partners.

This may include:

- Administration of the application process, including informing the decision about suitability for potential courses of study;
- Academic administration and to facilitate your education, including admission and registration, administering courses of study, organising professional placements, recording progress, agreeing awards, organising examinations, course transcripts and certificates;
- Administration of the financial aspects of your relationship with the University College or the partner and with any funders, for example the assessment and collection of fees and other monies due to the University or our partners;
- Management of your use of facilities and participation in events, for example production of a student card, provision of IT services, graduation, and other functions. HSU and our partners will be required to manage access to specific areas, such as the Library and may monitor access to certain buildings and rooms;
- Enabling effective communications with you;
- Operation of security, disciplinary, complaint and quality assurance processes and arrangements. We may monitor use of IT services to ensure adherence to the Acceptable Use Policy;
- Support of Health, Safety and welfare requirements;
- Production of statistics and research for internal and statutory reporting purposes;
- For students who wish to attend Health Sciences University Graduation ceremony, personal data (including your name, award and classification) will be published in the graduation programme booklet. This information may also be passed to third parties such as sponsors of student prizes. You may withhold your consent to your name being published for these purposes when you register online to attend the award ceremony or graduate in absentia. If the approved Educational Partner have their own graduation ceremony they will inform you of how your data will be used if you sign up to attend the event.

The basis for processing your information and how we use it

We may process your personal data because it is necessary for the performance of the contract we have with you or in order to take steps at your request prior to entering into a contract.

Sharing information with others

For the purposes referred to in this privacy notice and relying on the basis for processing as set out above, if you are enrolled directly with Health Sciences University, we may share your personal data with certain third parties. If you enrol directly with one of our approved Educational Partners, they will provide you with information relating to how they may share your data including with HSU.

If you are enrolled directly with HSU, you are given the opportunity to opt out of some of these data sharing arrangements, for example when you register with us, but you should carefully consider the possible impact of doing this. Unless an opt-out is in place, we may disclose limited personal data to a variety of recipients including:

- our employees, agents, contractors, individuals and organisations where there is a legitimate reason for their receiving the information, including:
 - third parties who work with us to provide student support services (e.g. counselling);
 - Social services, law enforcement or prevention agencies (e.g., if a safeguarding concern was identified);

- organisations operating anti-plagiarism software on our behalf (such as Turnitin®);
 - parents, guardians and next of kin (we would always endeavor to seek student's permission to do this, however there may be exceptional circumstances where this may not be possible e.g. serious safeguarding concern).
- those with an interest in tracking student progress and attendance, including:
 - student sponsors (e.g. the Student Loan Company)
 - current or potential employers (to provide references and, where students are sponsored by their employer and/or where you take part in a placement, to provide details of progress/attendance);
 - professional and regulatory bodies (e.g. Health Care and Professions Council, British Psychological Society etc.) in relation to the confirmation of qualifications, professional registration and conduct and the accreditation of courses;
 - government departments and agencies where we have a statutory obligation to provide information (e.g. Office for Students, the Higher Education Statistics Agency (HESA), the Home Office (in connection with UK visas and immigration), Council Tax and Electoral Registration Officers at relevant local authorities (for the purpose of assessing liability for Council Tax and for electoral registration purposes));
 - crime prevention or detection agencies (e.g. the police, the Department for Work and Pensions);
 - third parties conducting surveys, for example the National Student Survey.

Students' Union

If you enrol directly with Health Sciences University we share some of the information we hold about you (including your name, date of birth, nationality, gender, HSU email address and course of study) with the Students' Union at HSU if you opt in for membership at the point of registration.

Alumni Relations

If you enrol directly with Health Sciences University, certain elements of your personal data will be used for alumni activities, including sending HSU publications, promotion of alumni benefits, services, events and programmes. If you want your personal data to be used for any of these purposes, you will be given the option to opt in when you enrol with us. HESA

If you enrol directly with Health Sciences University, we will send some of the student information we hold to the Higher Education Statistics Agency ("HESA"). If you enrol directly with one of our approved Educational Partners, we may be required to send data to HESA. HESA collects and is responsible for the database in which HESA student records are stored. National Student Survey and Graduate Outcome Survey

Where applicable, we will pass student contact details to survey contractors to carry out the National Student Survey and surveys of student finances for the organisations identified by HESA in their data protection notices referred to above. These organisations and their contractors will use student's details only for this purpose and will then delete them.

About six months after graduation, each student will be contacted by HESA or a survey contractor acting on their behalf, to ask the student to complete the Graduate Outcomes survey.

Changes to your personal data

Please tell us promptly about any changes to the information we hold about you. This is particularly important for your contact details.

If you are enrolled directly with Health Sciences University we request that you please contact the Registry team via this email address if you wish to update your details: registry@aecc.ac.uk.

If you are enrolled directly with one of our approved Educational Partners, they will inform you of how to inform them about any changes to your information.

How long your information is kept

Subject to any other notices that we may provide to you, we may retain your personal data for a period of seven years after your association with us has come to an end. However, some information may be retained indefinitely by us in order to maintain your academic record and respond to requests for confirmation of results.

Full details of our retention periods are contained in our Records Retention Policy.

Your rights

You have the following rights:

- to obtain access to, and copies of, the personal data that we hold about you;
- to require that we cease processing your personal data if the processing is causing you damage or distress;
- to require us not to send you marketing communications.
- to require us to correct the personal data we hold about you if it is incorrect;
- to require us to erase your personal data;
- to require us to restrict our data processing activities;
- to receive from us the personal data we hold about you which you have provided to us, in a reasonable format specified by you, including for the purpose of you transmitting that personal data to another data controller;
- to object, on grounds relating to your particular situation, to any of our particular processing activities where you feel this has a disproportionate impact on your rights.

Please note that the above rights are not absolute, and we may be entitled to refuse requests where exceptions apply.

If you have given your consent and you wish to withdraw it, please contact the Academic

Registrar using the Registry contact details set out above. Please note that where our processing of your personal data relies on your consent and where you then withdraw that consent, we may not be able to provide all or some aspects of our services to you and/or it may affect the provision of those services.
